Welcome, Quorum and Process

- "GW" called the meeting to order. He noted that a quorum of EC members was present.
 - The EC approved unanimously the EC Meetings Minutes from Pre and Post Congress
 - The EC approved unanimously the EC Meetings Minutes from the Congress to be presented to the next Congress in 2019.

- New Competition structure:

Sezimovo Usti (U15+U18 men) moved to 2020 Keep the U16 WECh in Croatia in 2019 WECh 2019 Ostrava – to organize the tournament two weeks earlier Add U18 qualifier in 2019 close to U16 Kunovice 2020 – offer them to host either U15 in 2020 or U22 in 2021
