Dissolving ESF

AB: After discussions with Lars Sundin from CEB, issues arise with discussions with legal counsels from Switzerland and procedures to liquidate the Federation are a bit more complicated.

Recommendation is not to bring it to a vote.

IBAF and ISF never dissolved.

GW: Competition point of view everything can go under WBSC Europe. Legally, it is complicated.

ESF and CEB could be dormant corporations.

MNJ: I would go with the advice of our legal counsels. Sleeping entities could work.

EvS / YA / MJ: agree

PA: I want something written from the lawyer.

DC: agree with PA.

EvS: money transfer with no dissolution could have legal consequences for treasurer, president and board.

Proposal: to take it off the table as CEB is also saying the same thing.

Vote: 5-2 Approved
