RollCall at 13:15. 15 Federations present.

G Waage Comments to Technical and Competition report 2013:

All Reports circulated before meeting. No comments received back from Federations.

Changes of Competition regulation 2014:

Motion 1 from GBR, to revert to ISF procedure for allocating Championship teams to 1st Round-Robin Pools: Comments from BEL, DEN, IRE, ISR, GBR, UKR. Vote 5 For, 7 Against, 1 Abstain. Motion Failed.

Motions 2,3,4 & 5 from Scorekeeping Commission re Personal Awards and Scorekeeping Statistics: comments from G Waage: all accepted by Federations. DEN advocates more judgement to be used in awards as present stats-based Regulations have lead to anomalies.

G Waage agrees and outlines proposal to go to EC for Competition Regulations: Chair TC with SiC and EC to decide personal awards, from Page Teams only, <u>based</u> on statistics but with flexibility in the case of close percentage differences between pitchers / batters with very different activity levels. Suggestion well received.

New structure CR / TR 2014 – introduction:

G Waage outlines reason for documentation changes to CR Regulations for Competitors and TR Regulations for Organisers.

G Tobback outlines process for drafting and approval of re-organised documents, and thanks the Competitions Commission and TC members who contributed to the successful effort. M Jennings reminds Federations of the Schedules of Deadlines relevant to Team Organisers, for all 2014 Cups and Championships, and the Summary of Requirements for Host Organisers: all available for reference on the website.

Review competition situation 2014 / 2015:

Allocation ESCM, ESCCS, EChCW and EChJM: agreed as per latest published Calendar.

EChJW 2014 – trial flip coin for all games was proposed by Competitions Commission. After debate it was agreed that first Round Robin scheduling should seek to balance Home / Visitor games for all teams. Thereafter the 'senior' (for example 1st from Pool A vs 2nd from Pool B) team should have Home precedence, but in the case of two 'equal' teams from first RR (for example, 1st from Pool A plays 1st from Pool C), then a coin Flip should be made, as soon as possible after the pairing is known.

World Games 2017 in Wroclaw and hosting ESF competitions. Situation outlined by G Waage re the ESF intention to fully support the Games technically, and to allocate ESF 2015 Women's Cup and 2016 EChJW to Wroclaw in preparation and proving of facilities prior to 2017. ESF will monitor performance of the venue during the ESF events.

New competitions:

Super Cup Junior Women 2015. Agreed after debate that this competition should be instituted in an 'Open' format in the years between U19W Championships.

European Masters Games 2015 (Oct 1st through 10th, Nice, FRA) to be followed by ESF Masters Cup(s) in 2016 and beyond. G Waage outlined initiative of instituting ESF Masters' events, potentially in all disciplines if demand sufficient. Proposal well received.

Various:

Discussion on 'Stepping Out' Rule (new to ISF Rulebook 2014). This will be discussed and clarified for all ESF Umpires attending the planned Blue Convention in Rome, March 2014. Bob Stanton, ISF UiC, will be present.

Bulgaria offer help to any Federation present requiring information about facilities etc. at the venues where they will host this year. Similar Anton Kops for Rosmalen.

M Jennings reminds Federations present who intend to enter 2014 ESCCS that they should consider whether they need to qualify a Slowpitch umpire to ESF standard in anticipation of their obligation to provide one official for each team they send on a 2014 ESF event. GBR are hosting an ESF qualifying SP Course on 7th through 11th May, location near London.

G Waage thanks all for their participation and closes the meeting.
